RE: Spring 2023 Class Visitation

Welcome to Columbia Law School. We hope that your visit to Columbia will prove enjoyable and helpful to your learning as to which law school will best meet your educational and professional objectives.

We invite you to attend a sampling of law classes during your visit, and have attached a class schedule for your reference. Almost all classrooms (JG 102, JG 103, etc.) are located on the first floor of Jerome Greene Hall (JG), the main Law School building located one block north of the Office of Admissions, on the northeast corner of Amsterdam Avenue and West 116th Street. A few are located in William & June Warren Hall (WJ) on 1125 Amsterdam Avenue, between 115th and 116th Streets.

Registration for class visitation is required. Use the registration link (<a href="https://apply.law.columbia.edu/portal/jd\_office\_drop\_in">https://apply.law.columbia.edu/portal/jd\_office\_drop\_in</a>) to sign-up for class visitation by selecting the date of the class on the registration form. We also ask that you appear at the classroom door a few minutes before the class is to begin and to provide the faculty member the courtesy of notifying the professor that you will be observing that day. Faculty members prefer that you sit in the back of the classroom, but you may also ask the instructor if there is a particular area or seat in the classroom where you should sit. Please note that faculty members expect that you will stay for the entirety of the class so as to not disrupt the other students.

The Columbia University Visitor Center offers a guided historical tours Tuesdays at 10:00 a.m. You may also take a self-guided tour of the main Columbia University campus at your convenience from 9:00 a.m. to 5:00 p.m. at the Visitor Center. The Visitor Center is located in Room 213 of Low Memorial Library on main campus. To get to Low Library from Amsterdam Avenue, cross Amsterdam Avenue and enter through the campus gates at 116th Street and walk along College Walk. You will see Low Library (the domed building with columns) on your right.
