**1 William and June Warren Hall**  
1125 Amsterdam Avenue

Known as “Big Warren,” William and June Warren Hall is home to several departments central to the life of Columbia Law students.

The second and third floors house classrooms and quiet study rooms for individuals and groups. The fourth floor is the home of **Student Services** and the student lounge. The **Office of Admissions, Financial Aid,** and **Registration Services** are located on the fifth floor.

**The Office of International Programs** on the sixth floor offers information and counseling for students interested in international study abroad opportunities, dual degree programs, moot courts, internships, and post-graduate fellowships.



**The Office of Private Sector Careers** on the seventh floor provides students and alumni with comprehensive support to explore employment opportunities in the private sector.

**The Office of Public Interest/Public Service Law and Careers** is our resource center for internships and jobs in government and public service in the United States and abroad. Located on the eighth floor, PI/PS Office oversees our pro bono programs and hosts lectures and events on human rights and public interest issues.

**2 The Greenhouse**  
424 West 116th Street

This small red brick building contains offices for some of the Law School’s fourteen academic journals, including *Columbia Journal of Law and Social Problems* and *Columbia Business Law Review*.

**3 William C. Warren Hall**  
410 West 116th Street

This 10-story modern building, affectionately called “Little Warren,” houses the *Columbia Law Review*, Law School administrative offices, and additional classrooms.

**4 Jerome L. Greene Hall**  
435 West 116th Street

Home to many of the Law School’s classrooms and faculty offices, Jerome L. Greene Hall is our community’s largest building. Student groups frequently set up tables in the lobby for outreach. Multimedia monitors provide up-to-the-minute information about Law School events.



**The Donald G. Drapkin Student Lounge** on the third floor is a sunlit space for quiet reading that is also used for special events. The neighboring **Lenfest Café** is a convenient and convivial spot for all-day dining with outdoor seating on an expansive terrace.

Faculty offices and seminar rooms are spread across floors five through nine. In addition, our ten clinics occupy suites on the eighth and ninth floors, where clinic students can hold teleconferences and meet privately with clients to confer on their representation in a variety of legal matters.

**5 Arthur W. Diamond Law Library**  
435 West 116th Street, inside Jerome L. Greene Hall

The Law Library, which is located on the second, third, and fourth floors of Jerome L. Greene Hall, holds more than 400,000 titles in 65 languages. A guest pass is required to visit the library and may be obtained at the Office of Admissions.

**6 Charles H. Revson Plaza**

This landscaped sculpture garden bridges Amsterdam Avenue and connects the third floor of the Law School with Columbia University’s main campus. Dominated by Jacques Lipchitz’s 23-ton sculpture, *Bellerophon Taming Pegasus*, the plaza is a popular spot for studying or picnicking in warm weather.
